



ASSUMPTION OF RISK, WAIVER OF LIABILITY, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT FOR STUDY ABROAD PROGRAMS SPONSORED BY THE LOS ANGELES COMMUNITY COLLEGE DISTRICT

For and in consideration of my voluntary participation in a study abroad program (the "PROGRAM") sponsored by the Los Angeles Community College District (the "DISTRICT"), I, (*print first and last name*) _____, agree as follows:

- DISTRICT'S RELATIONSHIP WITH VENDOR.** I understand that the DISTRICT has contracted with an outside agency (the "VENDOR") to provide and/or organize housing, transportation and other services during the PROGRAM for my convenience. I further understand that VENDOR has its own particular requirements and policies I must follow.
- STUDENT CODE OF CONDUCT.** I acknowledge that I must adhere to the DISTRICT's Student Code of Conduct (LACCD Board Rules, Chapter 9, Article 8, available at: <http://www.laccd.edu/board%5Frules/documents/Ch.IX-ArticleVIII.doc>), and that failure to do so may subject me to student discipline by the DISTRICT, up to and including suspension or expulsion.
- CANCELLATION.** I acknowledge that if I must leave the PROGRAM before the PROGRAM's end, any refund of fees paid to the VENDOR will be handled according to the VENDOR's refund policies.
- INSURANCE.** I understand that the DISTRICT is strongly recommending that I obtain appropriate health insurance coverage for the PROGRAM's duration and valid for the location(s) I will be traveling to abroad. I further understand that the DISTRICT, through VENDOR, can provide me with information as to how to obtain such insurance.
- ASSUMPTION OF RISK.** I acknowledge that international travel and my participation in the PROGRAM carry with them significant risks, including, but not limited to, serious bodily injury or death, and property damage. I further acknowledge that my participation in the PROGRAM is entirely voluntary and that I am assuming such risks.
- WAIVER OF LIABILITY.** I hereby voluntarily release, discharge, waive and relinquish any and all actions or causes of action for personal injury, property damage, death, or loss of any kind whatsoever arising as a result of my participation in the PROGRAM. I hereby for myself, my heirs, executors, administrators and assigns, release, discharge, waive and relinquish any action or cause of action, aforesaid, which may hereafter arise for myself and for my estate, and I agree that under no circumstances will I or my heirs, executors, administrators and assigns prosecute, present any claim for personal injury, property damage, death or loss of any kind whatsoever against the DISTRICT, the DISTRICT's BOARD of TRUSTEES, the DISTRICT's officers, employees, agents, or representatives.
- INDEMNIFICATION AND HOLD HARMLESS.** I hereby for myself, my heirs, executors, administrators and assigns, agree that in the event any claim shall be prosecuted against the DISTRICT, the DISTRICT's BOARD of TRUSTEES, the DISTRICT's officers, employees, agents, or representatives, I shall hold harmless and indemnify the DISTRICT, the BOARD of TRUSTEES, the DISTRICT's officers, employees, agents, and representatives from any and all claims or causes of action by whomever or wherever made or presented for personal injury, property damage, death, or loss of any kind whatsoever.

By signing below, I acknowledge that I am at least 18 years of age, and that I have read the foregoing assumption of risk, waiver of liability, indemnification and hold harmless agreement, fully understand its terms, and understand that I am giving up substantial rights, including the right to sue. I acknowledge that I am signing this agreement freely and voluntarily.
