



ASSUMPTION OF RISK, WAIVER OF LIABILITY, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT FOR STUDY ABROAD PROGRAMS SPONSORED BY THE LOS ANGELES COMMUNITY COLLEGE DISTRICT (*For Minors*)

For and in consideration of the voluntary participation of my child, (*print child's first and last name*) _____ in a study abroad program (the "PROGRAM") sponsored by the Los Angeles Community College District (the "DISTRICT"), I agree as follows:

1. **DISTRICT'S RELATIONSHIP WITH VENDOR.** I understand that the DISTRICT has contracted with an outside agency (the "VENDOR") to provide and/or organize housing, transportation and other services during the PROGRAM for my child's convenience. I further understand that VENDOR has its own particular requirements and policies that my child must follow.
2. **STUDENT CODE OF CONDUCT.** I acknowledge that my child must adhere to the DISTRICT's Student Code of Conduct (LACCD Board Rules, Chapter 9, Article 8, available at: <http://www.laccd.edu/board%5Frules/documents/Ch.IX-ArticleVIII.doc>), and that failure to do so may subject my child to student discipline by the DISTRICT, up to and including suspension or expulsion.
3. **CANCELLATION.** I acknowledge that if my child must leave the PROGRAM before the PROGRAM's end, any refund of fees paid to the VENDOR will be handled according to the VENDOR's refund policies.
4. **INSURANCE.** I understand that the DISTRICT is strongly recommending that my child obtain appropriate health insurance coverage for the PROGRAM's duration and valid for the location(s) my child will be traveling to abroad. I further understand that the DISTRICT, through VENDOR, can provide my child with information as to how to obtain such insurance.
5. **ASSUMPTION OF RISK.** I acknowledge that international travel and my child's participation in the PROGRAM carry with them significant risks, including, but not limited to, serious bodily injury or death, and property damage. I further acknowledge that my child's participation in the PROGRAM is entirely voluntary and that we are assuming such risks.
6. **WAIVER OF LIABILITY.** On behalf of myself and my child, I hereby voluntarily release, discharge, waive and relinquish any and all actions or causes of action for personal injury, property damage, death, or loss of any kind whatsoever arising as a result of my child's participation in the PROGRAM. I hereby for myself and my child, my child's heirs, executors, administrators and assigns, release, discharge, waive and relinquish any action or cause of action, aforesaid, which may hereafter arise for us, and I agree that under no circumstances will I or my child, my child's heirs, executors, administrators and assigns prosecute, present any claim for personal injury, property damage, death or loss of any kind whatsoever against the DISTRICT, the DISTRICT's BOARD of TRUSTEES, the DISTRICT's officers, employees, agents, or representatives.
7. **INDEMNIFICATION AND HOLD HARMLESS.** I hereby for myself, my child, my child's heirs, executors, administrators and assigns, agree that in the event any claim shall be prosecuted against the DISTRICT, the DISTRICT's BOARD of TRUSTEES, the DISTRICT's officers, employees, agents, or representatives, we shall hold harmless and indemnify the DISTRICT, the BOARD of TRUSTEES, the DISTRICT's officers, employees, agents, and representatives from any and all claims or causes of action by whomever or wherever made or presented for personal injury, property damage, death, or loss of any kind whatsoever.

By signing below, I acknowledge that I am at least 18 years of age, and that I have read the foregoing assumption of risk, waiver of liability, indemnification and hold harmless agreement, fully understand its terms, and understand that I am giving up substantial rights, including the right to sue. I acknowledge that I am signing this agreement freely and voluntarily.
