The meeting was called to order by Acting Chair Terry Anderson at 5:50 p.m.

I. Welcome and Introductions

Members were welcomed. They were asked to introduce themselves. Ms. Diedra Stark introduced herself as a new member of the Citizens Building Oversight Committee. She recently retired from her post as Athletic Director at Los Angeles Valley College. She will represent the LAVC retirees association.

II. Approval of Minutes

Moved by Ms. Ballew and seconded by Mr. Calne, the minutes from the meeting of May 1 were approved unanimously.

III. Public Agenda Requests – None.

IV. President's Report – Membership Update

The moratorium is still in place. We have succeeded in releasing some construction projects.

Eloy Retamal, CPM, presented a college construction update. He confirmed that some of the major projects were released from the moratorium by the Board or Trustees. The projects released include the Monarch Center

building, the Athletic Training Facility, the Multipurpose Community Services Center, the parking structure, etc.

Projects that are still in moratorium include the Community Workforce Development Center, the Media and Performing Arts Center (MAPA) The demolition of all the old bungalows, improvement to parking lots and walk ways, and others.

The Panorama City Education Center project has been moved to horizon II, unfunded projects.

The construction of a canopy at the Student Services Center building is scheduled to be completed by the end of August. Student Services staff will be relocated in October to prevent interruption of student services during the first weeks of the fall semester.

Upcoming Events – Dr. Carleo announced the following events:

- On October 15 Los Angeles Valley College, the only community college in California designated as a Tree Campus USA, will participate in a national tree planting event sponsored and coordinated by the National Arbor Foundation.

Fifty trees will be planted along Burbank Boulevard. The media will cover this event. The committee was referred to the website under revitalize Valley College for more details.

Concern about the slow process in addressing projects under the moratorium was discussed. It was felt that Valley College is being penalized because of problems concerning other sites.
