Materials Needed

Reminders

- Students should use a **personal email address** they currently have access to and can receive emails.
- The CCCApply application times out after a few minutes. Please **save** your progress.
- Make sure students write down their **confirmation number** at the end of the application process.
- If using mobile phone or own computer, please make sure to turn off your VPN access.

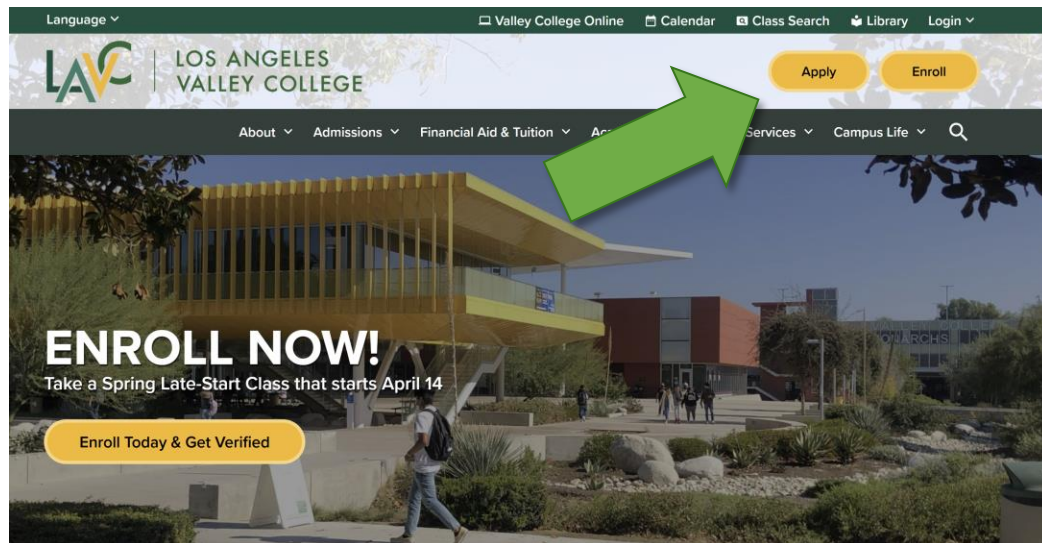

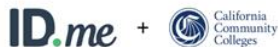

CCC Students Expected to Verify Their Identity with ID.me

The California Community Colleges (CCC) now use ID.me to help keep your identity safe and make it easier to apply to college and get financial aid.

Why Do I Need to Verify My Identity?

- Verifying your identity helps protect against someone else stealing it to apply for college or financial aid.
- If you skip ID.me verification, your college application may be put on hold until you verify who you are.
- Identity verification is required before you can get your financial aid.

What to expect:

- 1 Redirecting you to the ID.me website
- 2 Verifying your identity with primary or secondary documents
- 3 Returning you to your community college application

Decline Verification

The California Community Colleges know that some students might have trouble proving their identity with ID.me. This can happen if someone doesn't have a permanent address, social security number (SSN), or taxpayer ID number (ITIN), if there are issues with identity theft, or for some other reason. 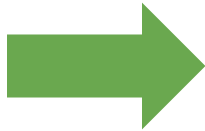

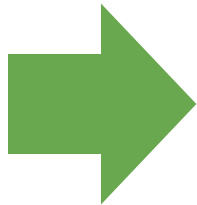

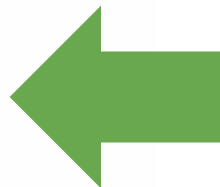
