- B. PURPOSE:

### **ARTICLE 2 MEMBERSHIP**

- A. ELIGIBILITY
  - i) Membership is open to all enrolled students of LAVC

### ARTICLE 3 OFFICERS AND ELECTIONS

- A. Titles and duties of officers
  - i) President to conduct all club meetings
  - ii) Vice President to assist president in conducting meetings
  - iii) Secretary to take notes during meeting and provide communication to all club members
  - iv) Treasurer to provide information on club budget, funds, and execute documentation and or processes for the club to access and utilize available funds
  - v) ICC Rep to represent the Veterans Club during ICC, provide updates regarding club events, serve as club liaison to ICC and ASU and communicate important updates and information related to clubs
- B. Elections of officers
  - i) Process of elections:
    - i. Elections are decided by a club member nominating themselves or another student

- ii. All club members who are present at the time of the meeting are eligible to vote
- iii. Majority vote wins
- ii) Eligibility of elections:
  - i. To be eligible for an office position in the club, the student must meet minimum academic standards of 2.0 GPA

# C. Special Elections

- i) Upon an emergency, a special election will be called during the next scheduled club meeting
- ii) The process of the special election will be the same a regular election in terms of election process and eligibility

## D. Term of Office

- i) Officers are elected for the current semester
- E. Special Requirements as to Scholastic Standing or Other Rules
  - i) All officers must be regularly enrolled and have a 2.0 GPA at the time of election and maintain a 2.0 GPA during their term of service
  - ii) All members of the club must be in good standing and maintain a 2.0 GPA
- F. Replacement Due to Ineligibility
